ORDER :

In pursuance of the agreement reached between Government and Samaikya Andhra Upadhyaya Porata Samithi, Teachers Joint Action Committee in the reference 1<sup>st</sup> read above, Government have permitted the Drawing and Disbursing Officer of School Education Department, in the reference 3<sup>rd</sup> read above, to draw and disburse the salary for the strike period from 22.8.2013 to 10.10.2013 (49) days to the teaching and non-teaching staff, who participated in Samaikya Andhra Poratam, in view of their compensating adjustment of working on (33) holidays from October, 2013 to March, 2014.

2. The President, APNGO's Association, Hyderabad in his representation, 4<sup>th</sup> read above, has stated that the Non-Teaching staff working in Govt. High Schools have participated in Strike from 13.8.2013 to 17.10.2013, protesting against division of State of Andhra Pradesh. He has stated after compensating the strike period of (49) days as per G.O. 3<sup>rd</sup> read above, a balance of (17) days, out of which (8) working days were left unsettled in respect of Non-Teaching staff, who participated in the strike. He has, therefore, requested the Government to issue necessary orders to enable the Non-Teaching Staff to draw their salaries etc., for remaining (17) days, who participated in Strike from 13.8.2013 to 17.10.2013.

3. In the reference 6<sup>th</sup> read above, Finance (FR-I) Department have issued orders for regularization of strike period as EL/ EL to be earned in respect of employees participated in the above strike.

4. After careful examination of the matter, Government have decided to treat the above balance period of (17) days of Non-Teaching Staff working in Government Schools, who participated in the said strike, as EL / EL to be earned, as per G.O.Ms.No.33, Finance (FR.I) Department, dated 04.02.2014.

5. Accordingly, Government hereby treat the balance period of (17) days of Non-Teaching Staff working in Government Schools, who participated in the said strike from 13.8.2013 to 17.10.2013, as EL / EL to be earned / Eligible Leave, as per G.O.Ms.No.33, Finance (FR.I) Department, dated 04.02.2014.
