I am to inform you that the Registrar, Institution of A.P.Lokayukta, Hyderbad in the letter cited furnished a copy of complaint for submission of report in duplicate to the Institution immediately. The details are as follows:

- A. There are about 257 unrecognised schools in Guntur District and action taken. All over Andhra Pradesh, several thousands of unrecognised schools are there.
- B. Infrastructure facilities and also the number of teachers required are very much deficient and action taken report.
- C. Teachers who were qualified to teach have opted to go to other places, particularly District hqrs and State hqrs on deputation basis, leaving the students in the lurch to receive the low quality education. (Details of teachers on deputation out of school i.e.in the O/O MEO, MDO, Dist.Level and State level).
- D. Building facilities and other amenities which are necessary and which are mandatory under the above law have not been provided so far and particularly girl students are dropping out because of the lack of toilets.
- E. From 1-4-2013, all the accommodation facilities and other mandates including infrastructure and also the quality elementary education by maintaining proper pupil-teacher ratio are mandatory and there should be 100% admission of the students in the age group of 6 to 14 and see that there are no dropouts and all these had to be managed by the C & DSE and the SPD, RVM (SSA).

I furnish herewith a copy of the orders of the Hon'ble Lokayukta and a copy of the complaint lodged by Smt K.Sowjanya, R/O Guntur with a request to submit detailed report by 27th of this month to this office without fail.
